**RESOLUTION OF THE BOARD OF FIRE  
COMMISSIONERS, PENNINGTON BOROUGH  
DISTRICT NO. 1, COUNTY OF MERCER, STATE  
OF NEW JERSEY, APPOINTING MELANIE SZUBA  
APPLEBY, ESQ AND MATTHEW DONOHUE, ESQ AS  
FIRE DISTRICT ATTORNEY FOR 2023**

**WHEREAS**, the Board of Fire Commissioners, Pennington Borough, District No. 1 have determined a need to retain the services of a fire district attorney; and

**WHEREAS**, the Board relies on the advice and expertise of its attorney when conducting its affairs and making decisions that affect the fire district; and

**WHEREAS**, said appointment is made as professional services exception under the Local Public Contracts Law under a non-fair and open process; and

**WHEREAS**, the Board recognizes the knowledge and experience of Melanie Szuba Appleby, Esq. and Matthew J. Donohue, Esq. of the firm Rothstein, Mandell, Strohm, Halm & Cipriani, PA in the field of laws pertaining to the operation of a fire district in New Jersey, and also her familiarity with the business of this fire district and its relationship with those districts with whom it interacts.

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Fire Commissioners, Pennington Borough, District No. 1, as follows:

1. Melanie Szuba Appleby, Esq. and Matthew J. Donohue of the firm Rothstein, Mandell, Strohm, Halm & Cipriani, PA be retained as attorney for the fire district for the calendar year 2023 at a fee of \$1,500 per month, plus expenses. She will provide transcription and document preparation services at a monthly fee of \$300.00.
2. The contract is awarded without competitive bidding under a non-fair and open and as a Professional Service in accordance with N.J.S.A. 40A:11-5(1)(a) of Local Public Contracts Law and a copy of the contract is on file and

3. If required, the contract shall be accompanied by the submission of a Business Entity Disclosure Certification and Political Contribution Disclosure Form pursuant to N.J.S.A. 19:44A-20.26.
