NOW, THEREFORE BE IT RESOLVED, by the Board of Fire Commissioners, Pennington Borough, District No. 1, as follows:

- 1. Joseph M. Carducci, CPA, of Bedard Kurowicki & Co., shall be retained for the calendar year 2024 as fire district Auditor and will prepare the fire district's 2023 annual financial audit and its annual 2023 LOSAP review at an amount not to exceed line item appropriated.
- 2. The contract is awarded without competitive bidding as a Professional Service in accordance with 40A:11-5(1)(a) of Local Public Contracts Law and the NJ Pay to Play regulations, if applicable. A copy of the contract is on file and available for public inspection at the fire district offices.
- 3. The contract shall require completion and submission of a Business Entity Disclosure Certification and Political Contribution Disclosure Form pursuant to N.J.S.A. 19:44A-20.26.
