PENNINGTON BOROUGH BOARD OF FIRE COMMISSIONERS TO AMEND ADOPTED BUDGET AND REQUESTING APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION PURSUANT TO N.J.S.A. 40A:14-78.5

WHEREAS, the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any fire district when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget pursuant to N.J.S.A.40A:14-78.5, and

WHEREAS, the Director may also approve the insertion of an item of appropriation for an equal amount, and

WHEREAS, the Pennington Borough Fire Commissioners has received \$50,000 from the Federal American Rescue Plan Firefighter Grant and wishes to amend the 2024 Fire District Budget to include this amount as revenue.

NOW, THEREFORE, BE IT RESOLVED, by the Chairman and Commissioners of the Pennington Borough Fire Commissioners, County of Mercer, State of New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2024 in the sum of \$50,000.00, which is now available as a revenue from:

American Rescue Plan Firefighter Grant

BE IT FURTHER RESOLVED, that the like sum of \$50,000.00 be and the same is hereby appropriated under the caption of:

American Rescue Plan Firefighter Grant

BE IT FURTHER RESOLVED, that the sum of \$5,000, representing the amount required for the Fire District's share of the undertaking and acceptance of said grant appears in the budget of year 2024 under the caption Fire Fighting equipment and is hereby re-appropriated under the caption of American Rescue Plan Firefighter Grant.

BE IT FURTHER RESOLVED, that one certified copy of this resolution be filed forthwith in the Office of the Director of Local Government Services and a certified copy of the resolution be filed in the NJ FAST system.
